**2.- COMPOSITION / INFORMATION ON INGREDIENTS**

Hydrogen Peroxide CAS N° 7722-8-1: 8.7 – 12.2%

**3.- DANGERS IDENTIFICATION:**

May cause skin and severe eye irritation. Harmful if swallowed. May cause severe irritation of gastric mucous membranes if swallowed. Prolonged contact with skin may whiten skin and cause burns. Decomposition yields oxygen and may support combustion.

**5.- ACCIDENTAL RELEASE MEASURES**

Steps to be taken in case material is released or spilled

For small spills, wipe out with paper or a sponge. Wash area with water. Rinse paper towels, sponges or mops thoroughly prior disposal or storage. For large spills, dike and contain free liquid. Use absorbent material to solidify spill and then place in UN specification drums for disposal.

**6.- FIRST AID**
